# Supply-Chain Management

#### **6-11 MAY 2013** KUALA LUMPUR MALAYSIA

The objective of this course is to provide participants with practical knowledge and skills needed for effective management of drugs and laboratory commodities needed in today's TB programmes. This course is taught by a PharmacistPM (pharmaceutical supply management) specialist and a TB doctor, each with more than 20 years experience in managing TB supplies in a wide range of countries. The techniques presented during lectures will be applied during realistic exercises and simulations. This course will provide participants with the required knowledge and skills to effectively manage the commodities needed in a contemporary TB programme.

Participants involved in HIV/AIDS programmes will also benefit from participating in the training as there is increasing collaboration and overlap with TB programmes and many of the topics covered can also be applied to the management of antiretrovirals and HIV diagnostics.

International staff and consultants involved in the forecasting, procurement, storage, distribution of TB related commodilies.

# Mass Media & Communications

Health programmes are realising more and more that in order for a national or local health project to be effective and reach its audience they need to have in place a communications plan that will enable them to deliver important health education messages to the public.

10-14 JUNE 2013 CAPE TOWN SOUTH AFRICA

Participants in this course have the opportunity to learn directly from experts working in global health communications. During the course, participants will engage in scenarios that they'll experience while implementing mass media campaigns and interacting with journalists to pitch health-related stories. They will also learn how to write press releases and how to create a communications plan for an organisation.

# Budget & Financial Management

Budgeting is one of the central elements that keeps a health project functioning. It touches all aspects of a health programme and can affect the outcome of any planned endeavor. This course provides participants with advanced training in the budget-development process for national health programmes. Participants will learn how to develop, manage, and monitor a budget, as well as understand how to cope with issues such as variance analysis, cash flow, and expenditures. In addition, the course equips participants with useful financial information, such as how to prepare for an audit and important accounting principles.

## Project Management

Project planning is one of the fundamental steps in managing health programmes. This six-day course equips participants with useful project management procedures to improve workflow. Participants learn about monitoring and evaluation techniques, how to bridge exiting resources with planned outcomes, properly assign tasks to partners, and conduct analyses to determine areas of improvement

# Influencing, Networking & Partnership

#### 23-27 SEPTEMBER 2013 CHICAGO UNITED STATES OF AMERICA

Programme managers need to balance many different roles and responsibilities in order to manage the changing needs of a national health programme. Networking with other health professionals in order to push through important initiatives is an essential task for any health manager. To develop partnerships, leaders must constantly work to build consensus among many different stakeholders who often have opposing interests, expectations, and goals.

This course trains participants in network building, establishing strong partnerships, gaining consensus for initiatives, managing conflict, and creating coalitions with other individuals or organisations to help with the implementation of their health initiatives.

Course fees include lodging (unless stated otherwise), breakfast, lunch, refreshments, and course materials. Course cost is 1,500 Euros.
